Overview

Heather specialises in professional liability and related insurance disputes, commercial litigation, and regulatory work.

Heather is ranked by both Chambers & Partners and Legal 500 for her professional liability work, and has variously been described as “exceptionally talented” and “an incredibly strong junior”. She acts for and against a wide range of professionals, with particular experience of claims against lawyers, surveyors, valuers, and financial professionals.

Heather also has substantial experience of professional indemnity insurance disputes. She appeared with William Flenley KC in the Court of Appeal in *Axis v Discovery Land Company* [2024] PNLR 16, the leading case on the meaning of the dishonesty exclusion in the solicitors’ Minimum Terms for insurance.

Professional Liability

Heather acts for claimants and defendants in claims involving all manner of professionals. She has particular experience of claims against lawyers, surveyors and valuers, and financial professionals. She is frequently instructed in cases which are particularly legally or factually complex, including as sole counsel against silks and leading juniors.

Lawyers

Heather has extensive experience of claims against lawyers, arising out of most areas of legal practice.

Her work includes claims arising from litigation gone wrong, including lost litigation and under-settlement claims; conveyancing and lender claims; claims arising from the conduct of family proceedings, including matrimonial finance disputes; and

claims arising from non-contentious transactions, including corporate transactions, tax planning schemes, wills and trusts.

Heather also has experience of advising on the professional conduct of solicitors, including matters relating to the Solicitors' Accounts Rules, confidentiality issues, and potential contempt proceedings.

Her current and recent cases include:

- defending a lost litigation claim arising out of failed employment tribunal and civil proceedings, said to be worth more than £7.5m
- acting for solicitors in an application by their former client to restrain the solicitors from acting for the former client's opponent in subsequent litigation (with William Flenley KC)
- various claims arising out of failed property investment schemes in the UK and abroad
- various claims against solicitors arising out of alleged frauds.

Property Professionals

Heather is regularly instructed in claims against property professionals, including claims against building surveyors, valuers, estate agents, and property managers. She is currently acting for a bank in a £8m professional negligence claim against a valuer in connection with mixed property development (with Nicola Rushton KC).

Financial Professionals

Heather has acted in a wide range of claims involving financial professionals, including accountants, IFAs, mortgage brokers, insolvency practitioners, and tax advisers.

Construction Professionals

Heather has experience of a number of claims against architects, quantity surveyors and engineers of various different specialisms, typically relating to residential property development.

Insurance

Heather often acts insurance coverage disputes, largely but not exclusively in relation to professional indemnity insurance. She has particular experience of advising on dishonesty and aggregation issues. She has also been instructed on various arbitration proceedings about solicitors' professional indemnity insurance and in arbitration claims about after the event insurance cover.

Her current and recent work includes:

- Acting, with William Flenley KC, in *Axis v Discovery Land*, above, a high profile coverage dispute arising out of a former solicitor's fraud

- *Fay of London Limited v Axis* [2025] EWHC 1334 (Ch), a claim under the Third Parties (Rights against Insurers Act) 2010 in respect of stolen client monies (with William Flenley KC)
 - Advising on coverage in respect of solicitors' professional indemnity policies following alleged thefts of client monies.

Commercial Law

Heather is instructed to advise on a broad range of commercial matters, including contractual claims, claims arising out of fraud and deceit, business and property disputes, shareholder disputes, and claims for breach of trust and breach of fiduciary duty.

Her current and recent work includes several cases involving allegations of actual or suspected fraud, recovery and enforcement claims, and claims for urgent relief.

Regulatory and Disciplinary

Heather has considerable experience of professional disciplinary work. She has represented professionals such as architects, midwives, and nurses in proceedings before their professional disciplinary body. She also has experience of advising on solicitors' regulatory disputes. Her work in this area includes the successful defence of allegations of misconduct and dishonesty regarding the condition of a baby at birth, which turned on the cross-examination of the various medical experts, and the successful defence of allegations that medication errors contributed to the death of a patient, in circumstances where the coroner had previously said that they did.
