Overview

Some of Nicola’s reported cases include:

- *Shaw v Stead* [2019] EWHC 520 – a GP claim relating to a delayed diagnosis of cauda equina syndrome
- *Bot v Barnick* [2018] EWHC 3132; [2019] EWHC 3704 – separate applications dealing with a strike-out of a claim, alleging negligent misstatement by a doctor, and issues relating to expert evidence
- *Doyle v Habib* [2021] EWHC 1733 – a claim relating to informed consent for liver surgery
