### **Inquests and judicial review**

He is regularly instructed in complex healthcare cases, including cases involving medicinal products and devices, and deaths in nursing homes. He also undertakes cases involving workplace accidents and road traffic accidents, where issues of sub-standard medical treatment arise. He has represented bereaved families, healthcare providers, employers, insurers, pharmaceutical and medical device manufacturers, and company officers. He undertakes a significant amount of related fatal accident litigation.

## Notable cases

- *Snow v Royal United Hospitals Bath NHS Trust* [2023] EWHC 42 (KB) A wide-ranging judgment dealing with the standard of care when introducing a new surgical technique to a hospital. It covers clinical governance, NICE and other guidelines, training, mentoring, supervision, documentation of patient selection and multi-disciplinary team decisions, *Montgomery* consent, and the documentation and conduct of the operation itself. - *R v Epsom & St Helier Hospitals NHS Trust*: Delay in diagnosis of brain tumour, blindness
  - *Turner v Southern Health NHS Foundation Trust*: Absconding psychiatric patient sustaining severe head injuries in RTA
  - *Walmsley (deceased)*: Inquest, investigation of potential role of insulin pump in diabetic's death
  - *Rhodes (deceased)*: Inquest, death of child with complex congenital heart defects whilst awaiting heart surgery
  - *Cowler (deceased)*: Inquest, fatal complications of stem cell transplant in clinical trial for Crohn's disease
  - *Hublely (deceased)*: Inquest, fatal haemorrhage complicating laparoscopic cholecystectomy absence of blood products on site, neglect verdict. A widely reported case which featured in a BBC Panorama documentary on fatalities at independent surgical treatment centres. An article on the case can be found .
